On June 28, 2016, United States Magistrate Judge Marilyn Heffley issued a Report and Recommendation, recommending that the petition be denied and dismissed. Petitioner filed a Rebuttal to the Report and Recommendation on August 11, 2016 (Docket No. 12), and subsequently filed an Addendum on August 31, 2016 (Docket No. 13). The arguments set forth in those documents do not address the basis for denial and dismissal of the petition set forth in the Report and Recommendation; specifically, that the petition is untimely and that Petitioner is not entitled to equitable tolling. I will therefore approve and adopt the Report and Recommendation, and dismiss the petition with prejudice without an evidentiary hearing.
