ORDER

AND NOW, this 20th day of October, 2017, upon consideration of Mr. Frazier’s motion to proceed *in forma pauperis* and his *pro se* complaint, [ECF 1], it is hereby ORDERED that:

1. The motion to proceed *in forma pauperis* is GRANTED.

2. The complaint is DISMISSED without prejudice for failure to state a claim, pursuant to 28 U.S.C. § 1915(e)(2)(B)(ii), and consistent with this Court’s Memorandum. Mr. Frazier is granted leave to file an amended complaint within thirty (30) days of the date of this Order in the event he can cure the deficiencies in his complaint. If Mr. Frazier files an amended complaint, he should identify all of the defendants in the caption of the amended complaint in addition to the body of the amended complaint, and shall describe how each defendant was responsible for violating his rights. Mr. Frazier should also clearly identify when he was allegedly wrongfully arrested. Upon the filing of an amended complaint, the Clerk of Court shall not make service until so ORDERED by the Court.

3. The Clerk of Court shall furnish Mr. Frazier with a blank copy of this Court’s current standard form to be used by a *pro se* litigant filing an action under 42 U.S.C. § 1983 bearing the above-captioned civil action number.

4. If Mr. Frazier fails to comply with this order, his case may be dismissed for failure to prosecute without further notice.
