AND NOW, THIS  $29^{\text{th}}$  DAY OF APRIL, 2016, IT IS HEREBY ORDERED THAT:

- (1) The Amended Report and Recommendation of Magistrate Judge Martin C.
  Carlson filed on September 24, 2015 (Doc. 67) is ADOPTED in part and NOT
  ADOPTED in part;
