¹ The Court is unable, at this time, to determine whether it has subject matter jurisdiction over this action. Plaintiff's Complaint does not set forth the legal basis for his cause of action, or set forth any detail as to where Mr. Harrison's actions took place, what injuries Plaintiff suffered, and any causal connection between Defendant's actions and Plaintiff's injuries. Further, because the Court is unaware of the legal basis upon which Plaintiff's claim is premised, the Court is unable to determine whether Defendant's removal of this action may have resulted in a waiver of its sovereign immunity defense.

Nonetheless, assuming that jurisdiction was proper, it is without question that Plaintiff has failed to plead adequate facts to state a claim upon which relief can be granted.
