MOTION FOR ARREST WARRANTS

AND NOW comes the United States of America, by its attorneys, Mary Beth Buchanan, United States Attorney for the Western District of Pennsylvania, and Soo C. Song, Assistant United States Attorney for said District, and, pursuant to Rule 9 of the Federal Rules of Criminal Procedure, respectfully moves the Court to issue an Order directing that an Arrest Warrant be issued for the apprehension of defendants ERIC ALFORD, a/k/a E Smith, a/k/a Dub, a/k/a E, STEPHEN E. BYNUM, JAMES HILL, a/k/a Jessie James, ANTHONY HOOTS, a/k/a Big Bone, WILLIAM MARSHALL, NAKEELA McCASKILL,

DAVID J. SCOTT, GIANTE L. THOMAS, DARRYL WALLAR, a/k/a D, a/k/a Wall, a/k/a D-Wall, BRIAN E. WELLS, and SIMEANIA YOUNG, upon the grounds that an Indictment has been returned in the above-captioned criminal case charging the defendants with conspiracy to distribute and possess with intent to distribute 5 kilograms or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance and 50 grams or more of a mixture and substance containing a detectable amount of cocaine base, in the form commonly known as crack, a Schedule II controlled substance, in violation of Title 21, United States Code, Section 846 (all defendants - Count 1); attempt to possess with intent to distribute 5 kilograms or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of Title 21, United States Code, Section 846 (Alford and Bynum - Count 2); possession with intent to distribute 50 grams or more of a mixture and substance containing a detectable amount of cocaine base, in the form commonly known as crack, a Schedule II controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(A)(iii) (Waller - Count 3 and Scott - Count 6); possession with intent to distribute a quantity of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C) (Wallar - Count 4); and attempt to possess with intent to distribute 500 grams or more of a mixture and substance


containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of Title 21, United States Code, Section 846 (Alford and McCaskill - Count 5) and Title 18, United States Code, Section 2.

Recommended bond: Detention.
