This is an action seeking habeas corpus relief. Petitioner is a detainee at the Charleston County Detention Center. Therefore, in the event that a limitations issue arises, Petitioner shall have the benefit of the holding in *Houston v. Lack*, 487 U.S. 266 (1988) (prisoner’s pleading was filed at the moment of delivery to prison authorities for forwarding to District Court). Under Local Civil Rule 73.02(B)(2) DSC, pretrial proceedings in this action have been referred to the assigned United States Magistrate Judge.

On May 29, 2014, the court issued an order directing Petitioner to provide documents necessary for initial review. (ECF No. 5.) Petitioner complied with the order and this case is now in proper form.

PAYMENT OF THE FILING FEE:

Petitioner requests to proceed without prepaying the filing fee by filing an Application to Proceed in District Court Without Prepaying Fees or Costs (Form AO-240), which is construed as a Motion for Leave to Proceed *in forma pauperis*. Based on a review of Petitioner’s Motion for Leave to Proceed *in forma pauperis*, it is granted. (ECF No. 8.)

TO THE CLERK OF COURT:

The Clerk of Court shall not serve the Petition upon the Respondent because it is subject to dismissal.
