INTRODUCTION

Upon appointment by the Honorable Joseph F. Anderson, Jr., United States District Judge, the undersigned has served as Special Master in this action and submits this Report at his direction.

This matter concerns a dispute concerning the production of certain documents prior to a trial in which the Plaintiffs seek injunctive relief. The trial is scheduled to begin on July 14, 2014.

By way of a motion, dated June 6, 2014, Plaintiffs sought an order compelling the Defendants to produce certain documents alleged to be privileged and for *in camera* review. Defendants filed a Response in Opposition to Plaintiffs' motion on June 16, 2014. All parties consented to appointment of a Special Master or Magistrate to review the documents for which the claims of privilege had been asserted.

On June 26, 2014, Judge Anderson appointed me to review the documents and report with respect to the Defendants' assertions of privilege.

On June 27, 2014, counsel for the Defendants provided me with a copy of the Plaintiffs' motion to compel production, a copy of the Defendants' response, and copies of the documents for which the Defendants have asserted various privileges.

Originally, the Defendants identified 321 documents for which they sought protection, generally based on assertions that the documents were protected by the attorney-client privilege, the doctrine of attorney work-product, or both. The documents now at issue consist of 66 documents for which the Plaintiffs requested *in camera* review. I have reviewed those 66 documents in light of the arguments contained in the Plaintiffs' Motion and in the Defendants' Response. Based on that review, I have reached the following conclusions and make the following recommendation concerning the Defendants' assertions of privilege for those documents.

CONCLUSIONS

1. With respect to the following documents, identified in "Documents Requested by Plaintiffs for Submission for *In Camera* Review," and contained in Notebook 3, and which Defendants provided to me ("Plaintiffs' *in camera* list"), I conclude that such documents ARE NOT protected by any privilege which the Defendants have asserted:


