- (d) Financial Account Numbers. If financial account numbers are relevant, the filer may include only the last four digits of these numbers.
- 2. <u>Protection of other sensitive personal information such as driver's license numbers and alien registration numbers may be sought under Rule 5.2(d)(filings made under seal) and (e) (protective orders).</u>
