On November 5, 2012, the United States Supreme Court in Lefemine v. Wideman, 133 S.Ct. 9 (2012), remanded the case to the United States Court of Appeals for the Fourth Circuit for a determination of whether special circumstances exist that would render an award of attorney’s fees to Lefemine, the prevailing party, unjust. Subsequently, the Fourth Circuit remanded the matter to this court for further proceedings consistent with the Supreme Court’s opinion. Lefemine v. Wideman, No. 10-1905 (4th Cir. Feb. 7, 2013). Based on the foregoing, the parties are ordered to file briefs within 20 days on the issue of attorney’s fees. Lefemine v. Wideman, 133 S.Ct. 9, 11 (2012).
