Narrative

ON 09-04-2010 AT 20:42 HOURS I RESPONDED TO A STRUCTURE FIRE AT 2715 HWY 360. UPON ARRIVAL I FOUND THE RESIDENCE TO BE FULLY ENGULFED IN FLAMES. COMPLAINANT CATHERINE DAUGHERTY ADVISED WHENEVER SHE RETURNED HOME FROM A SPORTING EVENT SHE SMELLED SMOKE IN THE AREA BUT DID NOT SEE ANY VISIBLE FIRE. I LATER SPOKE WITH EDDIE HAMMONTREE AND LARRY BOOKOUT WHO ADVISED THAT THEY WERE FISHING OFF HWY 360 NEAR THE RESIDENCE. BOTH ADVISED THAT THEY HEARD AN EXPLOSION WHEN LOOKING UP THEY OBSERVED WHAT LOOKED TO BE A MUSHROOM CLOUD IN THE AIR. BOTH SUBJECTS THEN RAN TO THE RESIDENCE TO MAKE SURE NO ONE WAS INSIDE THE RESIDENCE. IT WAS LATER DETERMINED THAT THE OWNER OF THE RESIDENCE CAROL STUTTE WAS IN NASHVILLE TENNESSEE DURING THIS INCIDENT. LOCAL VOLUNTEER FIRE DEPARTMENTS RESPONDED TO EXTINGUISH THE FIRE. LT. DETECTIVE JONES WAS CONTACTED AND RESPONDED TO THE SCENE TO FURTHER INVESTIGATE THE FIRE. AT THE TIME OF THIS REPORT THE CAUSE OF THE FIRE WAS UNDETERMINED.
