MEMORANDUM

This action, titled a "Habeas Corpus Motion to Appeal" was filed in the United States

District Court for the Southern District of Ohio and transferred to this Court. Although

of the conditions of his confinement in the Blount County Jail, including lack of access to

the courts and a denial of medical treatment. These are the same allegations raised by

petitioner in a case filed in this Court, which was dismissed as frivolous and for failure to

state a claim for relief. Rudolph M. Brooks v. Blount County, Tennessee, Civil Action No.

3:11-cv-363 (E.D. Tenn. November 15, 2011) (Memorandum and Order dismissing case).

For the reasons stated in the Court's prior Memorandum and Order, this action will

be **DISMISSED** as well. The Court will **CERTIFY** that any appeal from this action would

not be taken in good faith and would be totally frivolous. *See* Rule 24 of the Federal Rules of Appellate Procedure.
