

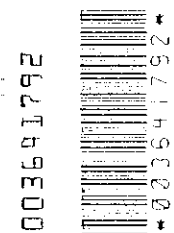

Information concerning renewal copyright

Two important points must be kept in mind with respect to renewal copyright: (1) the copyright term for a second term is 28 years from the date of publication, and (2) it can be claimed only by certain specified persons named in the law.

Time limits

If a work is published, the copyright term for published works lasts for 28 years from the date of publication in the case of a work originally registered or unpublished from the copyright term lasts for 28 years from the date of registration at the Copyright Office. In either case, the copyright may be renewed for a second 28-year term only if a claim is registered in the Copyright Office within the last 90th day of the original copyright term. For example, a work copyrighted in June 19, 1943, would be eligible for renewal between June 18, 1971, and June 18, 1972.

Caution: Unless a claim is made at the end of the first term at the Copyright Office because the first copyright term expired, copyright protection is lost permanently and the work enters the public domain. The Copyright Office has no discretion to extend the term of time limits.

How to register your claim

Send your renewal Copyright application for renewal registration to: Form RW-1, Renewal of Copyright, Copyright Office, Washington, D.C. 20540. The application should be accompanied by the registration fee of \$34. Do not send a copy of this form.

Who may claim renewal

In most instances, of four specific types of works, the law gives the right to claim renewal to the author and, if he or she is dead, to certain of his estate or beneficiaries as explained below. The next in order (priority) of a copyright claimant's claim remains in the cases listed in Paragraph B below.

A. The following persons may claim renewal if in living person work, except those mentioned in Paragraph B below:

- 1. The author, if living. State the claim as *author*.
- 2. The widow, widower, child or children of the author if the author is not living. State the claim as *author's widow*, *author's widower*, *author's child*, or *author's children*.
- 3. The author's executor, administrator, or personal representative.

B. In the case of a work copyrighted in the United States by an individual, the following persons may claim renewal:

- 1. If the work is a work first published and copyrighted in the United States, state the claim as *author*.
- 2. If the work is a work first published and copyrighted in the United States, state the claim as *author's widow*, *author's widower*, *author's child*, or *author's children*.
- 3. If the work is a work first published and copyrighted in the United States, state the claim as *author's executor*, *author's administrator*, or *author's personal representative*.
