ORDER

Pending before the Court are a Report and Recommendation of the Magistrate Judge (Docket No. 18) and a Motion to Amend Complaint and Objections filed by the Plaintiff (Docket No. 21). Pursuant to 28 U.S.C. § 636(b)(1), Fed. R. Civ. P. 72(b)(3) and Local Rule 72.03(b)(3), the Court has reviewed *de novo* the Report and Recommendation, the Objections, and the file. Even if the Court were to allow Plaintiff to change his cause of action, the Defendant's Motion to Dismiss would still be granted, as the immunity discussed therein applies to claims of malicious prosecution as well.
