
In the circumstances, we demand that you immediately:

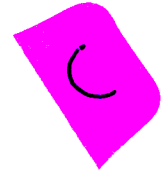

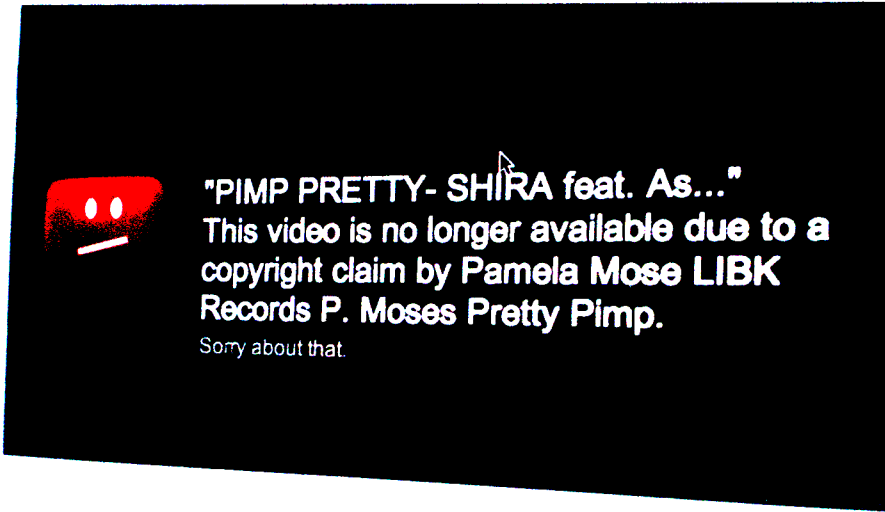

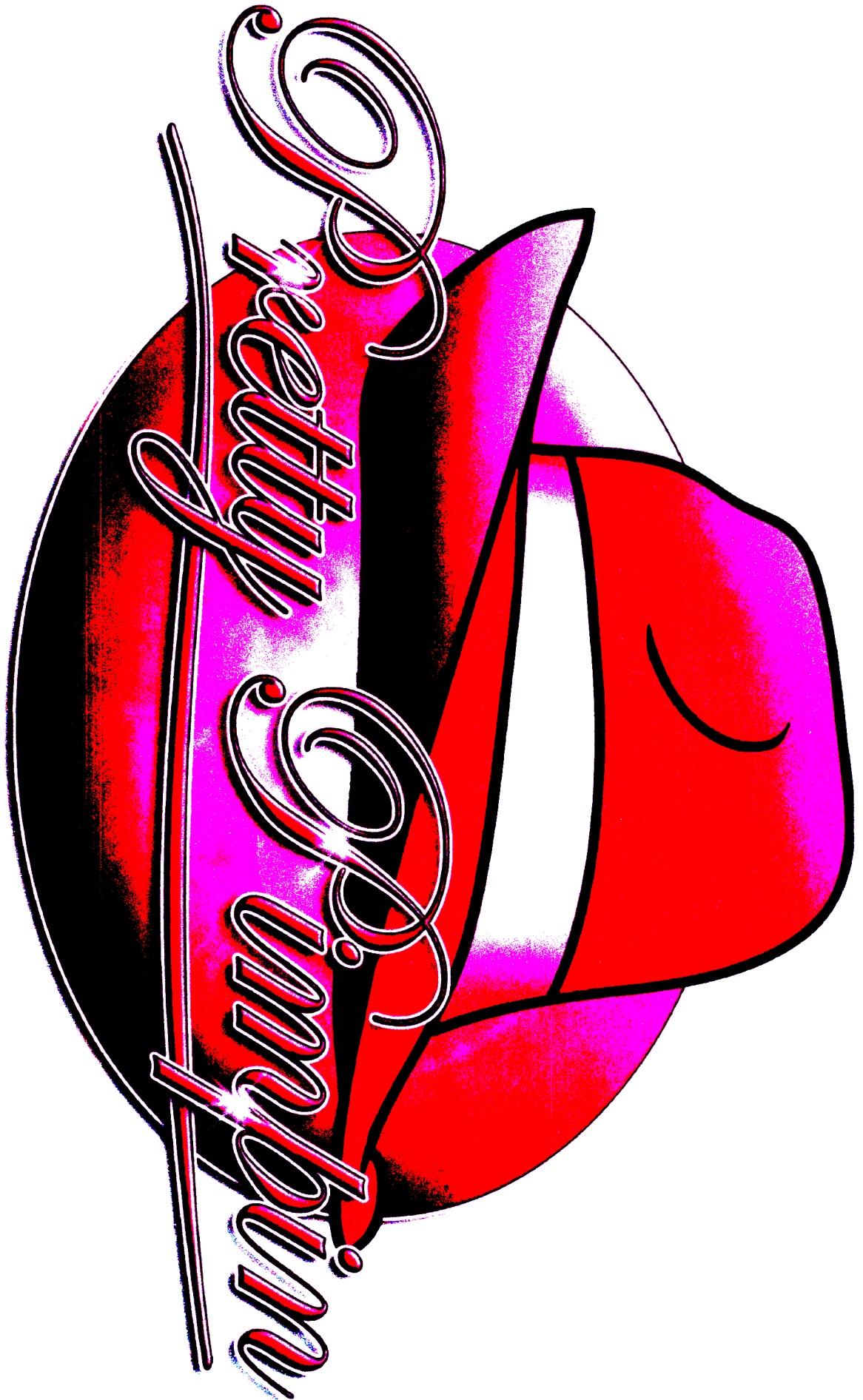
