AGREED MOTION TO EXTEND DEADLINES TO FILE A RESPONSE TO <u>PHOTOBUCKET INC.'S AND OTHER DEFENDANTS' MOTIONS TO DISMISS, AND</u> <u>REPLIES THERETO [Dkt. No. 42]</u>

Plaintiff FotoMedia Technologies, LLC ("FotoMedia") and defendants Photobucket.com. Inc. ("Photobucket"), Shutterfly, Inc. ("Shutterfly"), CNET Networks, Inc. ("CNET") and Yahoo! Inc. ("Yahoo!") (collectively, "defendants"), file this Agreed Motion to Extend Deadlines to file a Response to Photobucket's Motion to Dismiss (and the other defendants' motions, which join in the same), and, defendants' Replies Thereto and request the Court to extend the deadlines for FotoMedia to file its response to Photobucket.com, Inc.'s ("Photobucket") Motion to Dismiss [Dkt. No. 42] and the other defendants' joinders [Dkt. Nos. 43, 46, 47 & 48], and Photobucket's and the other defendants' replies thereto as follows:

1. On September 7, 2007, Photobucket filed its Motion to Dismiss Or, In the Alternative, for a More Definite Statement, Motion to Strike; and Memorandum of Points and Authorities in Support Thereof ("Motion to Dismiss"). Other defendants thereafter filed joinders in said motion. Pursuant to the Federal Rules of Civil Procedure and the Court's local rules,

FotoMedia currently must file a response to the Motions to Dismiss no later than September 24, 2007.

2. Photobucket's and the other defendants' replies to FotoMedia's response to the Motion to Dismiss are due no later than October 4, 2007.

3. FotoMedia's sur-reply to Photobucket's and the other defendants' replies is due no later than October 15, 2007.

4. In light of the issues identified in the motion, the parties have agreed to extend FotoMedia's response to the Motions to Dismiss by one week.

5. Accordingly, the parties request that the Court enter the Order submitted with this motion to allow FotoMedia to file its response to the Motions to Dismiss by no later than October 1, 2007, Photobucket and the other defendants to file their replies to FotoMedia's response to Motion to Dismiss by no later than October 22, 2007, and FotoMedia to file its surreply to Photobucket's and the other defendants' replies by no later than November 1, 2007.

This extension is not sought for delay. FotoMedia has met and conferred with counsel for Photobucket and Photobucket's and the other defendants' counsel agree with the requested extensions.
