CERTAIN SCHEDULING DEADLINES**


Before the Court is the parties' Joint Motion to Extend Certain Scheduling Deadlines. Having considered the matter, and the fact that it is a joint motion, the Court GRANTS the Motion and extends the following deadlines as reflected in the chart below:

Deadline for all parties to exchange any supplemental claim terms for construction. All parties agree that they will only supplement claim terms to the extent that a party believes in good faith that Plaintiff's new infringement contentions require such supplementation.		June 15, 2010
Deadline for all parties to exchange preliminary claim constructions and extrinsic evidence on supplemental claim terms or to modify preliminary claim constructions and extrinsic evidence exchanged on June		July 6, 2010

Deadline to amend pleadings (It is not necessary to file a Motion for Leave to Amend before the deadline to amend pleadings except to the extent the amendment seeks to add a new patent in suit. It is necessary to file a Motion for Leave to Amend After the amended pleadings date set forth herein.)	June 23, 2010	July 23, 2010
Deadline for all parties to supplement P.R. 4-3 chart on supplemental claim terms/modified constructions		July 28, 2010
