- 5. Hearing on Plaintiff's Motion for Class Certification: **December 1, 2010, 9:30 a.m.**
- 6. Deadline to file a *Daubert/Kumho* challenge to any expert witness designated in accordance with the Docket Control Order: **September 17, 2010.**
- 7. Plaintiffs may take the deposition of Defendants' expert, Dr. Itamar Simonson, after the close of discovery, namely, on a mutually agreeable date at the end of August, 2010.
