It is a mistake from Lodsys LLC. to implying that our application "MegaPoker Online" is infringement any of the claims on patent 7,222,078 or patent 7,620,565.

Our application "MegaPoker Online" version 1.3.7L or older versions are only provided a list of images that link with URLs of different versions on Apple's App Store. If user is clicking on any of those images, MegaPoker Online will open the URL from those links and then shut down completely. All is done on the client side ONLY without any interactions or communications to any of the servers. Links from one application to another App Store's apps are simple as open a URL from your web browser, such as this following link:

We had contacted Christopher M. Huck (Lodsys LLC. representative) explained our situation and discussed whether Lodsys LLC. should drop Combay Inc. from this case. The response from was that Lodsys LLC. will download MegaPoker Online to investigate further into it. If Lodsys LLC. still found that "MegaPoker Online" is infringement any of Lodsys's patents, please provide us with screenshots of the proofs. Screenshots much be more than one to be signifying that if Combay Inc. did or did NOT interact with any of the servers and/or Apple's In-App Purchase Module that Lodsys LLC. was claimed on patents '078 and '565.

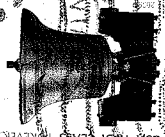

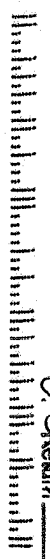
