GOOGLE'S UNOPPOSED MOTION FOR EXTENSION OF TIME FOR THE PARTIES TO FILE REPLIES IN SUPPORT OF EXPEDITED MOTIONS TO COMPEL DISCOVERY

Defendant Google Inc. ("Google") respectfully files this unopposed motion for extension of time for the parties to file any replies in support of their expedited motions to compel discovery.
