**PLAINTIFFS' DISCLOSURE OF  
PRELIMINARY ELECTION OF ASSERTED CLAIMS**

Pursuant to the Court's October 15, 2014 Order, Plaintiffs Rockstar Consortium US LP and NetStar Technologies LLC (collectively, "Rockstar") makes the following preliminary election of asserted claims.
