RESOLUTION

WHEREAS, The Texas House of Representatives is proud to pay tribute to the Dublin Dr Pepper Bottling Company on the historic occasion of its 100th anniversary, June 7, 1991; and

WHEREAS, Now the oldest Dr Pepper bottling plant in the world, the company was founded in 1891 by Sam Houston Prim, a Dublin entrepreneur who also operated a local icehouse, feed store, and coal business; though soda pops were considered something of a luxury at the time, the demand for Dr Pepper quickly grew, and Mr. Prim eventually sold a portion of his business to devote more time to bottling the popular soft drink; and

WHEREAS, Following Mr. Prim's passing in 1946, management of this successful enterprise was carried on by his daughter, Mrs. Grace Lyon, who ably piloted the business through a period of considerable growth and expansion; during these years, older machinery was replaced with the most modern equipment available, enabling plant workers to dramatically increase production to an unprecedented rate of 180 cases an hour; and

WHEREAS, Today, the Dublin Dr Pepper Bottling Company is still a family enterprise, skillfully overseen by veteran general manager Bill Kloster and his grandson, sales manager Mark Kloster; under their capable guidance, the plant has continued a proud tradition of growth and prosperity, as evidenced by the recent expansion project that added more than 12,000 square feet to the original facility; and

WHEREAS, The Klosters have also insisted on faithfully retaining the original Dr Pepper recipe, the only one of the company's bottlers to do so; though other plants switched to corn syrup sweeteners in 1979, Bill Kloster has continued making his blend with pure cane sugar, a more expensive choice but one that has earned him the undying gratitude of true Dr Pepper fans across the nation; and

WHEREAS, As befits a family business, the festivities surrounding the company's centennial celebration will overlap with a more personal occasion when Mr. Kloster and his wife, Iona, celebrate their 50th wedding anniversary a few days later, accompanied by their son, William Edward Kloster, and grandsons, Mark and Jeff; a vital part of the business herself, Mrs. Kloster has contributed her expertise as the plant's accountant and office manager for approximately 15 years; and
