Chris,

I need to see the breadth of his disclosure before I can fully understand the request. We will likely take issue with any disclosure that should have been made prior to now (specifically those that prejudice Bedrock's case due to the delay). While I wait to see your disclosure, can you please answer the following questions: Was Mr. Filo a document custodian? When will Mr. Filo's documents be produced? What is the reason for delaying his identification?

Bedrock is against any depositions occurring outside the discovery period. However, given that it is unlikely you can produce Mr. Filo's documents in time for a deposition next week, we will allow this deposition to occur after the discovery deadline. This is not an agreement to leave the discovery period open for anything other than this deposition (to the extent we agree to move forward with it). We will pencil in Mr. Filo's deposition for January 12th in your offices in Menlo Park.
