UNOPPOSED MOTION TO AMEND DOCKET CONTROL ORDER

These extensions are not requested for purpose of delay and do not affect the current trial setting. The parties have conferred, and Plaintiff Bedrock Computer Technologies LLC does not oppose the extension.
