**STIPULATION OF DISMISSAL**

Plaintiff Bedrock Computer Technologies, LLC (“Bedrock”) and Defendant Google, Inc. (“Google”) hereby (1) stipulate by and through their counsel of record pursuant to their settlement of all claims: (a) to vacate the verdict rendered in this matter, (b) to dismiss all claims and counterclaims asserted between Bedrock and Google at any time in the above-captioned matter **with prejudice**, (c) and that each party shall bear its own costs, expenses and attorneys’ fees.

Because the settlement of all claims between Bedrock and Google and this agreed upon Stipulation of Dismissal resolves and eliminates the need for any judgment pursuant to the verdict issued in this case, Bedrock and Google further jointly move the Court for an order vacating the verdict rendered in this matter and dismissing **with prejudice** all claims and counterclaims asserted in this litigation with each party bearing its own costs, expenses and attorneys’ fees.
