

Yahoo! Inc. (“Yahoo!”), as the prevailing party in this action, has submitted its agreed Bill of Costs in the amount of \$115,500.00. Yahoo! and Bedrock Computer Technologies LLC (“Bedrock”) met and conferred regarding Yahoo!’s Bill of Costs pursuant to the Court’s standing order pertaining to bill of costs. Based on Yahoo!’s requests and Bedrock’s objections thereto, the parties have negotiated and reached an agreement concerning the appropriate items to be included as recoverable costs when judgment is entered in favor of Yahoo!. The parties agree that the appropriate items to be included as reasonable costs amount to \$115,500.00. The agreed Form AO 133 reflects the agreed-to costs.

Accordingly, when judgment is entered in favor of Yahoo!, Yahoo! respectively requests that the Court enter an order requiring Bedrock to pay Yahoo! \$115,500.00 in satisfaction of the agreed Bill of Costs no later than 30 days after the date on which the clerk taxes the costs pursuant to Federal Rule of Civil Procedure 54(d).
