**JOINT MOTION FOR EXTENSION OF TIME TO FILE REPLY AND
SURREPLY TO YAHOO!'S MOTION TO DECLARE THIS AN EXCEPTIONAL CASE
AND FOR ATTORNEYS' FEES AND COSTS PURSUANT TO 35 U.S.C. § 285**

Plaintiff Bedrock Computer Technologies, LLC (“Bedrock”) and Defendant Yahoo! Inc. (“Yahoo!”) file this motion to extend the time to file a reply and a surreply to Yahoo!’s Motion to Declare This an Exceptional Case and For Attorneys’ Fees and Costs Pursuant to 35 U.S.C. § 285 and would respectfully show the Court the following:

Yahoo!’s current deadline to file a reply in support of its Motion to Declare This an Exceptional Case and For Attorneys’ Fees and Costs Pursuant to 35 U.S.C. § 285 [Dkt. No. 842] is July 11, 2011.
