## DECLARATION OF PAUL VAN CAMP, VICE PRESIDENT, PROPERTY MANAGEMENT OF DEFENDANT STAPLES, INC.

- I, Paul Van Camp, provide this declaration on behalf of Defendant Staples, Inc., and declare as follows on its behalf:
- 1. I have personal knowledge of the facts set forth herein. If called to do so, I could and would testify competently thereto.
- 2. I am employed by Staples, Inc. (hereinafter "Staples"). I make this declaration on behalf of Staples in support of the Joinder by Defendant Staples, Inc. in Motion to Transfer to the U.S. District Court for the Northern District of California Pursuant to 28 U.S.C. § 1404(a).
- 3. I joined Staples in 1998, and my current job title is Vice President, Property Management.

4. Staples is incorporated in the State of Delaware.

5. Staples is headquartered in the Commonwealth of Massachusetts with an address

of 500 Staples Drive, Framingham, Massachusetts.

6. As of January 30, 2010, Staples operated a total of 2,243 retail stores in 48 states

and the District of Columbia in the United States, in 10 provinces and 2 territories in Canada,

and in 12 other foreign countries. Of the 2,243 retail stores, 1,555 were located in the United

States.

7. As of May 19, 2010, Staples also had 325 non-retail facilities in the United States.

8. As of January 30, 2010, Staples operated 55 retail stores in the State of Texas. As

of May 19, 2010, Staples also had 18 non-retail facilities in the State of Texas. As of the latter

date, Staples had 11 retail stores and one non-retail facility in the Eastern District of Texas.

9. As of January 30, 2010, Staples operated 216 retail stores in the State of

California. As of May 19, 2010, Staples also had 29 non-retail facilities in the State of

California. As of the latter date, Staples had 39 retail stores and six non-retail facilities in the

Northern District of California.
