DEFENDANTS' NOTICE OF SUPPLEMENTAL AUTHORITY IN SUPPORT OF TRANSFER TO THE NORTHERN DISTRICT OF CALIFORNIA

Defendants file this Notice of Supplemental Authority in Support of Transfer in light of the Federal Circuit's June 24, 2010 Order in *In re Zimmer Holdings, Inc.*, Misc. Docket No. 938 (Fed. Cir. June 24, 2010), attached as Exhibit A. In this case, transfer was required in light of the substantial conveniences in trying the case in the transferee district and because "the only connection between this case and the plaintiff's chosen forum is a legal fiction." *Id.* at 8. This decision is further pertinent to Defendants' pending motion to transfer with respect to the following holdings:

- Plaintiff's decision to claim its principal place of business in the chosen forum requires close scrutiny. *Id.* at 5.
- Plaintiff's presence in the forum is entitled to no weight if it "appears to be recent, ephemeral, and an artifact of litigation." *Id.* at 6.
