**JOINT MOTION OF PLAINTIFF AND DEFENDANTS FOR EXTENSION OF  
DEADLINE TO RESPOND TO AMENDED PLEADINGS**

The Plaintiff and Defendants jointly move this Court to extend the deadline to respond to Amended Pleadings until Monday, January 31, 2011. That deadline is currently set for Thursday, December 30, 2010.

The parties request this change in light of *Eolas' Unopposed Motion for Extension of the December 16, 2010 "Amended Pleadings (Pre-Claim Construction)" Deadline Until January 17, 2011* (Doc. #528), which this Court granted on December 15, 2010 (Doc. #529).
