
In accordance with the “Final Award of Arbitrator” in the above-referenced action, we enclose herewith, on behalf of Xstreamlok, a check made payable to Uniloc in the sum of [REDACTED]. This amount includes two components. The first component is the reimbursement of \$2,250 for Xstreamlok’s portion of the administration fees, as per paragraph 3 of the “Final Award” section on page 24. The second component is the [REDACTED] U.S. dollar equivalent of the [REDACTED] set forth in paragraph 2 of the “Final Award” section on page 24, converted using the official rate of exchange as reported by the *New York Times* on October 1, 2009.

Please be advised that, in accordance with the understanding of the parties and as per paragraph 5 of the “Final Award” section on page 25, we reserve the right to seek full reimbursement of the [REDACTED] component of this payment if Uniloc fails to establish that the relevant Xstreamlok technology was covered by the ‘216 patent, because if (as Xstreamlok and Symantec contend) it was not so covered, then as everyone has recognized, there was no royalty obligation to begin with.
