**PLAINTIFFS' NOTICE OF DECISION REGARDING  
DEFENDANT SYMANTEC CORP.'S MOTION TO DISMISS FOR IMPROPER VENUE**

Plaintiffs Uniloc USA, Inc. and Uniloc Singapore Private Limited file this notice of decision to advise the Court of an order by the United States District Court for the Central District of California relevant to Defendant Symantec Corp.'s ("Symantec") pending motion to dismiss for improper venue (Dkt# 60). In its motion to dismiss, Symantec urges this Court to dismiss this action in favor of a second-filed declaratory judgment suit involving the same patent asserted in this case, the '216 patent, based on claims that a prior stipulation in an earlier suit required that any future disputes be filed in the Central District of California. On January 14,

2011, Judge David O. Carter entered an order, attached hereto as Exhibit 1, that denied Symantec's motion to enjoin Plaintiffs from proceeding against Symantec in this action and transferred Symantec's second-filed declaratory judgment suit to this Court, rejecting Symantec's reading of the prior stipulation.

The now transferred action has been received by this district's clerk and assigned case number 6:11-CV-33.
