PATENT ASSIGNMENT

This PATENT ASSIGNMENT (the "Assignment") is entered into as of January 26, 2011, from Uniloc (Singapore) Private Limited (the "Assignor"), to Uniloc Luxembourg S.A. ("Assignee").

WHEREAS, in connection with a corporate restructuring, Assignor, a wholly-owned subsidiary of Assignee, has agreed to assign rights to certain intellectual property assets to Assignee;

WHEREAS, Assignor is the owner of all of the right, title and interest in and to U.S. Patent No. 5,490,216, filed 9/21/1993 with the United States Patent and Trademark Office and issued 2/6/1996 entitled: "System for Software Registration" (the "U.S. Patent");

WHEREAS, the U.S. Patent, together with all continuation, re-examination, reissue or divisional applications thereof, and any and all rights under an assignment agreement dated January 27, 1994 between Fredric Richardson III and Assignor, are collectively defined herein as the "Patent Rights"; and

WHEREAS, Assignor desires to transfer, assign and convey to Assignee, and Assignee desires to acquire, all of Assignor's right, title and interest in and to the Patent Rights on the terms and subject to the conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and conveys to Assignee and its successors in interest and assigns, the full and exclusive right, title and interest in and to the Patent Rights, in the United States of America and all foreign countries, including the right to claim priority under the laws of the United States, the Paris Convention, the Patent cooperation Treaty, and any foreign countries, for the full term of the Patent Rights, including extensions of time thereof, the same as if held by Assignor had this Assignment not been made (the "Assignment"). The Assignment includes the assignment of the right to recover for all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patent Rights, including, without limitation, all causes of action and other enforcement rights for:

- (i) damages, profits, and awards of whatever nature (past, current and future), and
- (ii) injunctive relief, and
- (iii) any other remedies of any kind for past, current and future infringement; and
- (iv) all rights to collect royalties and other payments for liabilities under or on account of any of the Patent Rights, including provisional rights under 35 U.S.C. § 154(d).

Assignor covenants that Assignor is the lawful owner of all of the right, title and interest in and to the Patent Rights, and the patents and inventions which may result therefrom, and further covenants that no assignment, sale, agreement or encumbrance has been or will be entered into which would conflict with this provision or with the Assignment contemplated by this Assignment, except for the license created by the provisions of that certain License

Agreement by and between Assignor and Uniloc USA, Inc., a Texas corporation, dated September 22, 2003, as amended.

Assignor covenants and agrees to cooperate with Assignee in the execution and delivery of all instruments or documents requested for the making and prosecution of any applications of any type in the United States and in all foreign countries which relate to the Patent Rights, and the patents and inventions relating thereto, including, but not limited to the following: provisional, continuation, continuation-in-part, divisional, renewal or substitute, reissue, re-examination, or extension. Assignor further covenants and agrees that Assignor will communicate to the Assignee, its successors, assigns and legal representatives, any facts known to Assignor respecting the Patent Rights, and any patents and inventions relating thereto, and will testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything reasonably possible to aid the Assignee, its successors, assigns and legal representatives, to obtain and enforce proper protection for the Patent Rights, and any patents and inventions relating thereto, in all countries.

Assignor requests the Commissioner of Patents and Trademarks to issue said Letters Patent of the United States of America to Assignee, and requests that any official of any country or countries foreign to the United States, whose duty it is to issue or grant patents and applications, issue said Letters Patent, Utility Model Registration or Inventor's Certificate to Assignee.
