**UNOPPOSED MOTION TO EXTEND DISCLOSURE DEADLINES OF THE  
ERICSSON AND SONY ERICSSON DEFENDANTS**

Under the Court's Docket Control Order and Discovery Order, the Defendants' deadline under Patent Rule 3-4(a) and under Paragraph 2.B of the Joint Agreed Discovery Order is September 14, 2011.
