<p>May 24, 2013</p>	<p>Defendants' amended/supplemental trial exhibit lists in light of Wi-LAN's recently produced documents due.</p> <p>Defendants' Supplemental Video and Stenographic Deposition Designations for depositions taken after March 19, 2013, due. Each Defendant who proposes to offer deposition testimony shall file a disclosure identifying the line and page numbers to be offered.</p>
<p>May 31, 2013</p>	<p>Wi-LAN's Rebuttal Designations and Objections to Supplemental Deposition Designations due. Cross examination line and page numbers to be included. In video depositions, each party is responsible for preparation of the final edited video in accordance with their parties' designations and the Court's rulings on objections. Wi-LAN's amendment/supplement to trial exhibit list limited to any issues raised by any exhibits or designations added in Defendants' amended/supplemental trial exhibit list or amended/supplemental deposition designations.</p> <p>Wi-LAN's objections to Defendants' amended/supplemental trial exhibit lists due.</p>
<p>May 31, 2013</p>	<p>Defendants' Supplements to existing Summary Judgment Motion and <i>Daubert</i> Motion, if necessary. Supplements shall be no more than 5 pages each.</p>
<p>June 3, 2013</p>	<p>Parties' Supplements to Existing Motions in Limine, if necessary, due. Supplements shall be no more than 5 pages each. The parties are directed to confer and advise the Court on or before 3:00 o'clock p.m. the day before the pre-trial conference which Motions in Limine are agreed to and which need to be addressed at the pre-trial conference.</p>
<p>June 7, 2013</p>	<p>Defendants' Objections to Wi-LAN's Rebuttal Designations to Supplemental Deposition Designations due. Defendants' objections to Wi-LAN's amended/supplemental trial exhibit list due.</p>
<p>June 14, 2013</p>	<p>Responses, if necessary, to Supplements to existing Summary Judgment Motion, <i>Daubert</i> Motion, and Motions in Limine due. Responses shall be no more than 5 pages each.</p>

June 25, 2013	<b>9:00 a.m. PRETRIAL CONFERENCE</b> at the United States District Court, 211 W. Ferguson, 3rd Floor, Courtroom of Judge Leonard Davis, Tyler, Texas. All pending motions will be heard. Lead trial counsel must attend the pretrial conference.
July 1, 2013	<b>9:00 a.m. JURY SELECTION and JURY TRIAL</b> at the United States District Court, 211 W. Ferguson, 3rd Floor, Courtroom of Judge Leonard Davis, Tyler, Texas.
