**DEFENDANTS' UNOPPOSED MOTION TO  
EXTEND THE DEADLINE TO FILE THE AGREED BILLS OF COSTS**

On July 16, 2013, the Court entered final judgment in favor of Defendants Alcatel-Lucent USA Inc. ("Alcatel-Lucent"), Telefonaktiebolaget LM Ericsson and Ericsson Inc. (collectively, "Ericsson"), Sony Mobile Communications AB and Sony Mobile Communications (USA) Inc. (collectively, "Sony Mobile"), and HTC Corporation, HTC America Inc., and Exedeia Inc. (collectively, "HTC") in a patent lawsuit filed by Wi-LAN Inc. ECF No. 470. The Court entered an amended judgment on July 22, 2013. ECF No. 471. In its judgment, the Court ordered that "Defendants' costs of court should be taxed against Plaintiff" and directed the Parties to the Court's Standing Order Regarding Bill of Costs.

Based on the date of the original judgment, the deadline for Defendants' bill of costs is currently July 30<sup>th</sup>, 2013. Per L.R. CV-54(b), the Parties are currently working on preparing agreed bills of costs, but require more time to identify and resolve any disputes. Therefore, Defendants respectfully request the Court to extend the deadline to file the agreed bill of costs by one week to August 6, 2013. This extension is not sought for delay and no other deadlines in this case will be affected. Wi-LAN does not oppose this motion.
