**DEFENDANTS' UNOPPOSED MOTION TO EXTEND DEADLINE TO SUBMIT TRIAL EXHIBITS**

On October 7, 2013, the Court granted the Joint Motion to Seal Certain Trial Exhibits, and ordered the parties to submit to Chambers a disk of the unsealed exhibits and a disk of the sealed exhibits within fourteen days, or by October 21st. In assembling the disks containing Defendants' exhibits, counsel for the Ericsson and Sony Mobile Defendants determined that three of the Defendants' physical exhibits (DX-205, DX-280, and DX-283) were in the possession of counsel for Alcatel-Lucent USA Inc., which was dismissed from this action in September.
