7. Mr. Martin is a McKool Smith employee whose usual and customary billing rate is \$185.00/hour. Mr. Martin is a Graphics Specialist who received his Bachelor of Science degree in architecture from the University of Texas at Arlington in 1976 and has over thirty years of graphics design expertise.

8. Mr. Martin's experience in industrial design and engineering prototypes was used to accurately represent the working of the infringing Nintendo controllers. Mr. Martin disassembled the controllers and many of the components (potentiometers and injection molded elements) to create mechanically functional 3D animation. From technical documents and exemplars, Mr. Martin created 3D cross-sections of accelerometers to illustrate structure and operation. Mr. Martin converted figures from Mr. Armstrong's patent application into 3D forms

to illustrate and animate mechanical operation. Mr. Martin also supervised the preparation of video depositions and exhibits for trial presentation.

Mr. Martin prepared cross-examination PowerPoints to be used to cross-examine Nintendo's experts. Mr. Martin also produced graphic boards and document enlargements for use at trial. Mr. Martin operated the PowerPoints throughout the entirety of the trial.
