

6. The parties will negotiate and file a stipulated protective order governing confidential materials on or before Friday, October 14, 2011.

7. Discovery of electronically stored information (“ESI”) will be conducted according to the protocols agreed upon by the parties.

8. Service of documents in this action can be sent via email. Service via email will be equivalent to personal service under FRCP 5(b)(2)(A) for purposes of calculating deadlines under FRCP 6(d). Documents e-filed with the Court via ECF do not need to be served, via email, or otherwise, per Local Rule CV-5(b)(1).
