The Report and Recommendation<sup>1</sup> issued by United States Magistrate Judge Evelyn J.

Furse on January 11, 2018 recommends<sup>2</sup> that all of Plaintiff Parker Malmstrom's claims<sup>3</sup> against

the State of Utah and the Utah Department of Child and Family Services be dismissed without

prejudice for failure to state a claim, or because of their Eleventh Amendment Immunity or

because neither constitutes a "person" subject to suit under 42 U.S.C. § 1983.<sup>4</sup>

The parties were notified of their right to file objections to the Report and

Recommendation within 14 days of its service pursuant to 28 U.S.C. § 636 and Fed. R. Civ. P.

72.<sup>5</sup> As Plaintiffs were mailed a copy of the Report and Recommendation, they were provided an additional three days to file their objection under Fed. R. Civ. P. 6(d). Because the last day of the 17 day period to file an objection would have been Sunday, January 28, 2018, the objection period was extended one day until the end of Monday, January 29, 2018 under Fed. R. Civ. P. 6(a)(1)(C).

On January 30, 2018, Plaintiffs filed a document entitled "Objection to Magistrate's Decision and Order Or Motion to Set Aside Magistrate's [sic]."<sup>6</sup> The document does not specify which Report and Recommendation is the subject of the objection and its content does not appear to relate to this Report and Recommendation. In addition to the lack of specificity, the filing<sup>7</sup> is untimely as to this Report and Recommendation. Because no party filed a timely written objection to the Report and Recommendation as provided by court rules,<sup>8</sup> and because the analysis and conclusion of the Magistrate Judge are sound, the Report and Recommendation<sup>9</sup> is adopted in its entirety.

## ORDER
