Objections to the Report and Recommendations

The Honorable Dale A. Kimball and Samuel Alba

I had hearing August 15,2006. I don't trust judge Samuel Alba, because he demonstrated his interest on EBay's side. Since he started hearing, he demonstrated his behavior and remarks: I made decision already. He didn't care about absence of ACE coins' attorney for unknown reasons. Judge told, presence of this attorney is not necessary.

Judge told admirable about Ebay company. Judge cannot make it in courtroom. He demonstrated his highest level of respect to Ebay's attorney. He gave defendant to tell his position first. He didn't interrupt attorney. Ebay's attorney demonstrated, he's personally familiar with members of court, when he went to judge room after hearing.

I presented myself. I couldn't find an attorney, who has been practice in civil rights' protection in Utah. Judge didn't allow to explain my position. He interrupted my each word. He demonstrated plaintiff and defendant have non-equal rights even in courtroom. Judge demonstrated he read only defendants' motions before hearing. When I started to tell about evidences about defendants' discriminative actions against me, he read these evidences only during court hearing.

Nobody notify me about presence third parts in courtroom. I don't know their names, but they had some authority, because judge looked on them, trying to get their opinion.

If I could know about this dishonest hearing, I could notify mass media to come for this hearing. I hope, you cancel results of previous 'hearing' and set up another hearing with another judge, who can be **impartial** to both parties. My case is about civil human rights in USA. Now judge tries to make decision to allow racial national and ethnic discrimination by Ebay Co. According American Bill of Rights any company has no advantage comparable with person. If this decision can be effective, it demonstrates absence of court protection of human rights in USA. It will become a precedent. It means, any huge company can destroy any person. I hope to restore my reputation and human dignity in your court. Other way, I'm ready to proceed even to Supreme Court of USA. I believe in democracy in USA. I hope to restore my human rights.

I understand, Ebay has corruption system, where its members are sure in any support of Ebay and now Utah's court system (upon circumstances of my case and court's report). Powerful seller Robert Baganza (defendant #3), which is not found by court yet, sent me e-mail (see attachment #), where he mentioned about physical destroy for me. Ebay covers this person. It didn't give his address to me. **Judge ignored this evidence and my complaint against R.Baganza.**

I'm asking to protect my life from Ebay Co. and its members. I'd like to get restriction order for my protection from Ebay Co. , Ace coins and Robert Baganza.

About Report and Recommendations:

1. This court document is a copy of Ebay's motion. It means, court didn't analyze evidences at all. Judge didn't hear case, he just demonstrated own opinion and support of Ebay Co, because it's 'famous company'.
2. During hearing I mentioned so-named 'agreement' is automatic registration without real signing by parties. This 'agreement' is only formal way to have relations between buyers, sellers and Ebay on auction items. It regulates just specific questions with buying-selling items.

Ebay demonstrated its racial ethnic national discriminative policy, when Ebay inc. broke up (without my permission) 'agreement'. It means, 'agreement' was invalid, when Ebay started to destroy my reputation and human dignity. Some sellers refused to send my items, when Ebay broke up my registration. People from many countries e-mailed me. They don't believe in possibility to protect human rights in USA.

I don't think, they are right. I'd like to prove, USA can protect people of different nationalities, races, ethnics. I'd like to ask a court to punish EBay, who put itself above Law and Constitution of USA. Any company cannot discriminate anybody.

I'm a patriot of USA. I'm a resident of USA, who has same rights as other Americans, based on Constitution of USA. I'll become a citizen in several months. I believe in democracy and human rights here. I hope to protect my human rights through court system. Many people are asking me about my court hearing.

During hearing I stressed about evidences of discrimination, which hold place **after** cancellation of agreement by Ebay.

Judge made decision, which is based on invalid 'agreement'. He didn't remark about this evidence in his report. But court should have stenography from hearing, which can prove it.

I proved in courtroom, Ebay has corruption system, where most powerful sellers are supported and coordinated by Ebay authority in realization of Ebay's racial ethnic

national discriminative policy. I read appropriate phrase(attachment #) from Ace coins confession . 'Go back to your own country... I have my own representative who contacts me personally...Do you think they (EBay) want to deal with little idiots like you or people like me who make them thousands of dollars a month.. I blocked you from everything'.

EBay confirmed his above info and EBay's discriminative policy, when **(in 1 hour after my e-mail to EBay !!!)** EBay cancelled my registration and my other deals with different sellers, who wrote positive feedbacks about me.

3.Judge tried to protect Ebay and to avoid its responsibility. Judge copied phrases into his report from Ebay's motion about Forum. Judge ignored the fact, that these Ace coins' phrases have been approved and organized by Ebay **before** putting them in Feedback (see my arguments and evidence above). This is confession of Ace coins: 'I have already let her (Ebay) know about you'. These racial ethnic national discriminative feedbacks are just some part of Ebay's guilty. Judge ignored my several evidences about other active actions of Ebay. I stressed and read all evidences in courtroom. He even didn't mention about them in his report.

I sue Ebay inc. for several active actions against my civil rights, because it demonstrated its racial ethnic national discriminative policy, which based on mutual financial interests with another defendants. According to confession of Ace coins, it's thousands dollars each month.

My case is under Law 1983 and Constitution of USA.

I hope to protect and restore my civil rights during new court hearing in Utah.
