Claim about restore of my reputation and human dignity and compensation in

amount \$13000000 (thirteen millions of dollars)

I'd like to file a claim against defendants, who abolished my civil rights on base of Constitution of United States of America.

On ebay acecoins put feedback with abusive words, which are connected with my national background. He did it twice, according to copy of internet page (attachment #1). He wrote me e-mail with more abusive words(attachment #2). He wrote about his support by one of ebay's representative(attachment #2). I contacted ebay and stress, that they cannot allow anybody to propagandize national discrimination on their pages. They didn't answer on this e-mail. I asked them to stop this guy, because he used ebay to throughout this appeal to national discrimination in USA. I asked them, is it policy of ebay to support such people? I didn't get any answer. I'd like court can decide about it. Common practice says, if ebay didn't answer on my e-mail, it shares this point of view. Further actions of ebay can demonstrate, they do racist policy. Ebay and acecoins had preliminary agreement. They destroyed my reputation and human dignity among hundreds people, I had deal with. It was happened in greatest democratic country of the world-USA. They had infringed the reputation of USA. I ask court to protect me from racist attacks and national intolerance on ebay pages. This site is visited by millions of peoples in the world. What these people can think about democracy in USA?

When I noticed ebay, I was going to sue them, they stopped my activity on ebay and supported acecoins (attachment #3 and 4). Ebay's actions mean their racist position in my case.

American laws avoid the discrimination of people on national, race, religious principles.

I'm permanent resident of USA and a person, who has equal rights with Americans, who were born here.

I'd like to get decision of court about such expressions:

There are acecoins words about me: THSI PERSON NEEDS TO GO BACK FROM WHAT EVER PLANET THEY CAME FROM!!! (2006, February 16) and

PLEASE GO HOME TO YOUR PLANET AND STAY OFF EBAY!(February 20, 2006) (attachment #1)

This is e-mail from wolfes014@aol.com, who is director of acecoins according registration form in ebay.

He wrote by his words (attachment of his e-mail #2):

Go back to your own country, obviously by the way you speak you are not from America and as for contacting eBay, I am a POWER SELLER, I have my own representative who contacts me personally. Believe me I have already let her know about you. Do you think they want to deal with little idiots like you or people like me who make them thousands of dollars a month.

Also I have spamed your email and blocked you from everything.

If ebay and acecoins allow such expressions, they should be responsible for them.

If ebay made privileges for some members, it cannot abolish rights of others.

I'd like to add some more info about this case. This acecoins has ebay protection, because all my remarks about his activity have been withdrawn by ebay. It means, other people cannot know true about him. It's also proof of ebay's position in my case (attachment #3).

I add the copy of ebay actions against me, which can stress their dishonest behavior.

I won some bids, paid for them, got positive feedbacks from 26 people from different countries. Ebay supported acecoins and cancelled them (attachment #4).

I'd like to restore my human dignity and reputation. I had difficult time during last month. I had been in hospital. My life has been destroyed, because I almost lost the trust in myself. I have been in depression; I couldn't have normal life, study and work. I haven't money to hire a lawyer, but I need to protect myself. I hope for restore of my life and democracy principles.

I'd like to ask a court to get info about defendant #3, who has nick in ebay greatupnorth. According attachment #5 his name is Robert Baganz, but ebay didn't allow to open his registration info.

I'd like to stress about his national abusive expressions. He should be responsible for them.

I'd like to stress, eBay makes a policy of national discrimination, when it allows to put national abusive expressions on website. It protected 2 defendant and shown own position, when it cancelled my registration.

Based on Constitution of United States of America about equal rights for all nationalities, circumstances of my case, I'd like to ask court:

1. To put responsibility for discrimination of my rights and destroy of my reputation and human dignity on all defendants.
2. To impose a penalty in amount 9 millions of USD on eBay to restore my reputation among thousands people in world. It allows to put national discrimination info and supported 2 defendants in it.
3. To impose a penalty in amount 2 millions of USD on defendant #2 (ACE COINS)
4. To impose a penalty in amount 2 millions of USD on defendant #3(Robert Baganz)
5. To arrest the assets of all defendants to protect my interests till decision on my case will be made.
6. To restore my nick in ebay to give me chance to contact and inform ebay's customers about this situation and court decision.
