### Notice of appeal

I had hearing August 15,2006. I don't trust judge Samuel Alba, because he demonstrated his interest on EBay's side. Since he started hearing, he demonstrated his behavior and remarks: I made decision already. He didn't care about absence of ACE coins' attorney for unknown reasons. Judge told, presence of this attorney is not necessary.

Judge told with admiration about EBay company. Judge cannot make it in courtroom. He demonstrated his highest level of respect to EBay's attorney. He gave defendant to tell his position first. He didn't interrupt attorney. EBay's attorney demonstrated, he's personally familiar with members of court, when he went to judge room after hearing.

I presented myself. I couldn't find an attorney, who has been practice in civil rights' protection in Utah. Judge didn't allow to explain my position. He interrupted my each word. He demonstrated plaintiff and defendant have non-equal rights even in courtroom. Judge demonstrated he read only defendants' motions before hearing. When I started to tell about evidences about defendants' discriminative actions against me, he read these evidences only during court hearing for first time. Upon my opinion judge didn't read the evidences in advance, because judges of Utah Central division court made decision before hearing to stay on rich EBay's side.

Nobody notify me about presence third parts in courtroom. I don't know their names, but they had some authority, because judge looked on them, trying to get their opinion. If I could know about this dishonest hearing, I could notify mass media to come for this hearing. I hope, your appeal court can cancel dishonest decision of Utah Central division

court and set up another hearing with another judge, who can be impartial to both parties. My case is about civil human rights in USA. Now judges made decision to allow racial national and ethnic discrimination and hatred in USA by rich famous racist EBay Co. The judges (Samuel Alba and Dale A. Kimball) cancelled American Bill of Rights, which doesn't allow any discrimination.

According American Bill of Rights any company has no advantage comparable with person. Upon this decision and precedent Law court demonstrated absence of court protection of human rights in USA. It means, any huge company can destroy any person. I hope to restore my reputation and human dignity. I'm ready to proceed even to Supreme Court of USA. I believe in democracy in USA. I hope to restore my human rights.

I understand, EBay Co. has corruption system, where its members are sure in any support of EBay Co. Now Utah's court system set up priority of any big company (as racist EBay Co.) above Federal Law.

Utah's Central division court ignored defendants' threat of physical violence against me, which took place in my case. I asked about restriction order for my protection against me. Court ignored my appeal, which means it allowed the violence against me.

All information and evidences about this threat can be find in my case (see attachments and my objections).

Court dismissed all defendants, even Robert Baganza (who threaded to physical destroy for me upon my national background). Court ignored my appeal and didn't find his address. Now this decision of Utah's court is license to kill me by defendants.

I'm afraid for my life, because I recover the system and structure of multimillions money laundry by EBay Co. I told about it in court hearing. All evidences are in my case.

Judges protected EBay Co. and ignored my remarks about black cash and money laundry by corrupted EBay Co. The judges didn't made any notification to IRS. I'm legal permanent resident of USA, who pays all taxes. I notified IRS about this structure for investigation.

I proved all details in courtroom, EBay Co. has corruption system, where most powerful sellers are supported and coordinated by EBay authority in realization of EBay's racial ethnic national discriminative policy. I read appropriate phrase from Ace coins confession in attachment in my case. 'Go back to your own country... I have my own representative who contacts me personally...Do you think they (EBay) want to deal with little idiots like you or people like me who make them thousands of dollars a month.. I blocked you from everything'.

**I'm afraid to be killed by rich racist Ebay Co. and its high sellers.**

**I'm asking a court to protect my life from Ebay Co. and its members. I'd like to get restriction order for my protection from Ebay Co. , Ace coins and Robert Baganza.**

I believe in justice in USA. Even I haven't an attorney, I hope impartial and honest court decision.

I have 3 defendants in 3 different states (California, Michigan). My case is under Law 1983 and Constitution of USA, which allowed to choose venue in Utah.

Court granted EBay's motion to dismiss for improper venue.

I ask Appeal court to cancel decision of Utah Central division court and set up new impartial and honest court in any place, where we can put 3 defendants for hearings. I hope to meet all defendants in courtroom. I would like to get decision, when all defendants are present. Utah Central division court made decision in all defendants favor without appearance Ace Coins and Robert Baganza in courtroom. I'd like to see their KKK-faces.

Court ignored all my evidences without any explanations, which I put into my objections to Report and Recommendations.

1. Court's Report and Recommendations is a copy of Ebay's motion. It means, court didn't analyze evidences at all. Judges didn't hear case, he just demonstrated own opinion and support of Ebay Co, because it's 'famous company'.

2. During hearing I mentioned so-named 'agreement' is automatic registration without real signing by parties. This 'agreement' is only formal way to have relations between buyers, sellers and Ebay on auction items. It regulates just specific questions with buying-selling items.

EBay demonstrated its racial ethnic national discriminative policy, when Ebay Co. broke up (without my permission) 'agreement'. It means, 'agreement' was invalid, when EBay started to destroy my reputation and human dignity. EBay's demonstrated its discriminative policy, when (in 1 hour after my e-mail to EBay !!!) EBay cancelled my registration and my other deals with different sellers, who wrote positive feedbacks about me. Some sellers refused to send my items, when EBay broke up my registration.

During hearing I stressed about evidences of discrimination, which hold place after cancellation of agreement by EBay Co.

Judge made decision, which is based on invalid 'agreement'. He didn't remark about this evidence in his report.

Court illegally granted EBay's motion to dismiss for improper venue. Court's decision is based on desire of famous racist company to avoid any penalty for its racial ethnic national discriminative policy.

People from many countries e-mailed me. They don't believe in possibility to protect human rights in USA.

I don't think, they are right. I'd like to prove, USA can protect people of different nationalities, races, ethnics. I'd like to ask a court to punish racist EBay Co, who put itself above Law and Constitution of USA.

I'm a patriot of USA. I'm a resident of USA, who has same rights as other Americans, based on Constitution of USA. I'll become a citizen in several months. I believe in democracy and human rights here. I hope to protect my human rights through court system. Many people are asking me about my court hearing.

My case is under Law 1983 and Constitution of USA.

I hope to protect and restore my civil rights during new court hearing.
