Plaintiffs Dazzlesmile, LLC and Optimal Health Science, LLC ("**Plaintiffs**") and Defendants Jesse David Willms, Farend Services Limited, 1021018 Alberta Ltd., Neverblue Media, Inc., Epic Advertising, Inc., Azoogole.com, Inc. and Azoogleads US, Inc. (collectively, the "**Parties**") hereby stipulate, pursuant to DUCivR 54-1 and DUCivR 77-2 as follows:

1) Responsive pleadings for defendants Jesse David Willms, Farend Services Limited, 1021018 Alberta Ltd., Epic Advertising, Inc., Azoogole.com, Inc. and Azoogleads US, Inc. are due on May 21, 2010. Responsive pleadings for defendant Neverblue Media, Inc. are due on May 24, 2010.
