Google Home Income is a scam program that has reoccurring billing. It claims to send you a CD for \$1.95 shipping cost and then they start billing you after 7 days for \$59.95 per month, and they enroll you in two additional memberships that charge you \$14.95 and \$9.95 a month.

To my knowledge, no one has ever received the CD within the 7 day trial, allowing them enough time to examine the CD material, so they are charged the \$59.95 anyway. Plus, if they do not cancel in time they are also charged for the 2 additional membership fees.

They make it very hard understand all of this before you join. Their Terms and Conditions lettering is very small and the placement is not easily discovered. They make it very difficult to cancel.

Please take time to report these scammers to Google. They are using the Google name for a scam, internet theft and deception.

Your website is not associated with the scam by the same name.

It is unfortunate that you share a name with scammers. You should be after these people as well as the scam busters, who are helping the FTC, by reporting everything that their investigations turn up. For instance it, the scam program, is involved with a publicly traded company called Pacific Webworks based in Utah. Further investigation shows that 30% of all of the Google cash, Google income, and Google Kit, type of scams that are active on the internet today, are also related to Pacific Webworks. You should add that in no way are you, or your site, affiliated with, or associated with, these scammers in your disclaimer on your site. It may help.
