Lt. Mays,

We have a small piece of software that will sit on either someone's computer that has an ODBC connection to the server or the server, which ever you prefer. That piece of software has a query that calls to the server each night, at the time you specify, to pull down certain pieces of information that you want to display on our website. This is usually crime type, date, time, identifier, and anything else you wish. Our integration engineer will help you decide on those pieces of information during integration. It pulls that information down to our CrimeReports publisher and then the publisher pushes the information to our website, so we don't keep any direct connections to your server, we keep it very secure that way. The publisher does this each night and it is automated so once we have done the integration you don't need to do anything else. We will watch your data and if, for some reason, it hasn't uploaded in a few days we will contact you to get the data feed back up and running. It is usually as simple as the computer was turned off or the password for the computer changed. We can get it fixed quickly for you. You do have complete control of the data so you will have access to an admin tool where you can delete or change crimes or stop certain crimes from being uploaded. We can also do this for you, you can just give us a call.
