My comments:

- 1 – None of the cities he mentions have provided data to SpotCrime in response to an open records request. No agency in the country has ever provided data to SpotCrime as an ongoing feed in response to an open records request.
- 2 – Washington DC and Dallas have feeds that anyone may use. He is scraping the Atlanta and Philadelphia PD Web sites.
- 3 – He does not have any signed contracts with agencies, period. If he says he does, you should ask him to produce copies of the executed documents so you can review the specific provisions in detail.

I'll track down the usage numbers. We serve about 500,000 users per month network wide.

Steven - I think the main thing I hope you can point out to the group is that the SJPD should look at this request strictly from an open records perspective as if CrimeReports.com were not involved at all. My rationale:

- 1 - SJPD has never paid CR anything, so there is no financial relationship whatsoever between us.
- 2 - We have not accessed data under open records laws in any form.

Finally, please reiterate to the team that this would set an incredible precedent, and will likely result in a flood of requests for other kinds of data as well from many city agencies. Unless the police department and the city are prepared for that, I would advise against it, but of course it's your counsel's call.

I may have some more thoughts about it later as well.
