I, Tom Cabral, under penalty of perjury, declare and say that:

1. I am an individual over the age of 18, and have personal knowledge of the facts set forth herein.

2. I am a process server in Boston, Massachusetts.

3. On Thursday, July 21, 2011, I was contracted to serve a summons and complaint upon a certain Peter Jarowey ("Mr. Jarowey") by the law firm of Pia Anderson Dorius Reynard & Moss, LLC ("PADRM") through an attorney at the firm, Ta'afili Sagapolutele ("Mr. Sagapolutele"). See Email on 07/21/2011, attached hereto as Exhibit A.

4. On Friday, July 22, 2011, I attempted service upon Mr. Jarowey at 214 Windsor Road in Waban, Massachusetts, but there was no answer at the door. See First Email on 07/22/2011, attached hereto as Exhibit B.


5. I took a photograph of Mr. Jarowey's residence located at 214 Windsor Road and sent it to Mr. Sagapolutele. See Second Email on 07/22/2011 with Picture, attached hereto as Exhibit C.

6. On Saturday, July 23, 2011, I returned to Mr. Jarowey's residence and knocked on the door. A gentleman answered the door and I introduced myself as a process server. I asked the gentleman if he was Peter and he said yes. I then proceeded to serve him the summons and complaint provided me by Mr. Sagapolutele. Upon completion of service upon Mr. Jarowey, I sent an email to Mr. Sagapolutele which stated: "Served Peter at 1pm July 23." See Email on 07/23/2011, attached hereto as Exhibit D.

7. The man at the residence identifying himself as "Peter" was an adult whom I presumed was Peter Jarowey. It is possible that there was another man at the home also named Peter.

8. On Tuesday, July 26, 2011, I faxed a copy of the Proof of Service of the summons and complaint upon Mr. Jarowey to Mr. Sagapolutele. See Fax on 07/26/2011, attached hereto as Exhibit E. On the Proof of Service, I indicated that "I personally served the summons" on Mr. Jarowey at 214 Windsor Road in Waban, Massachusetts. See *id.*

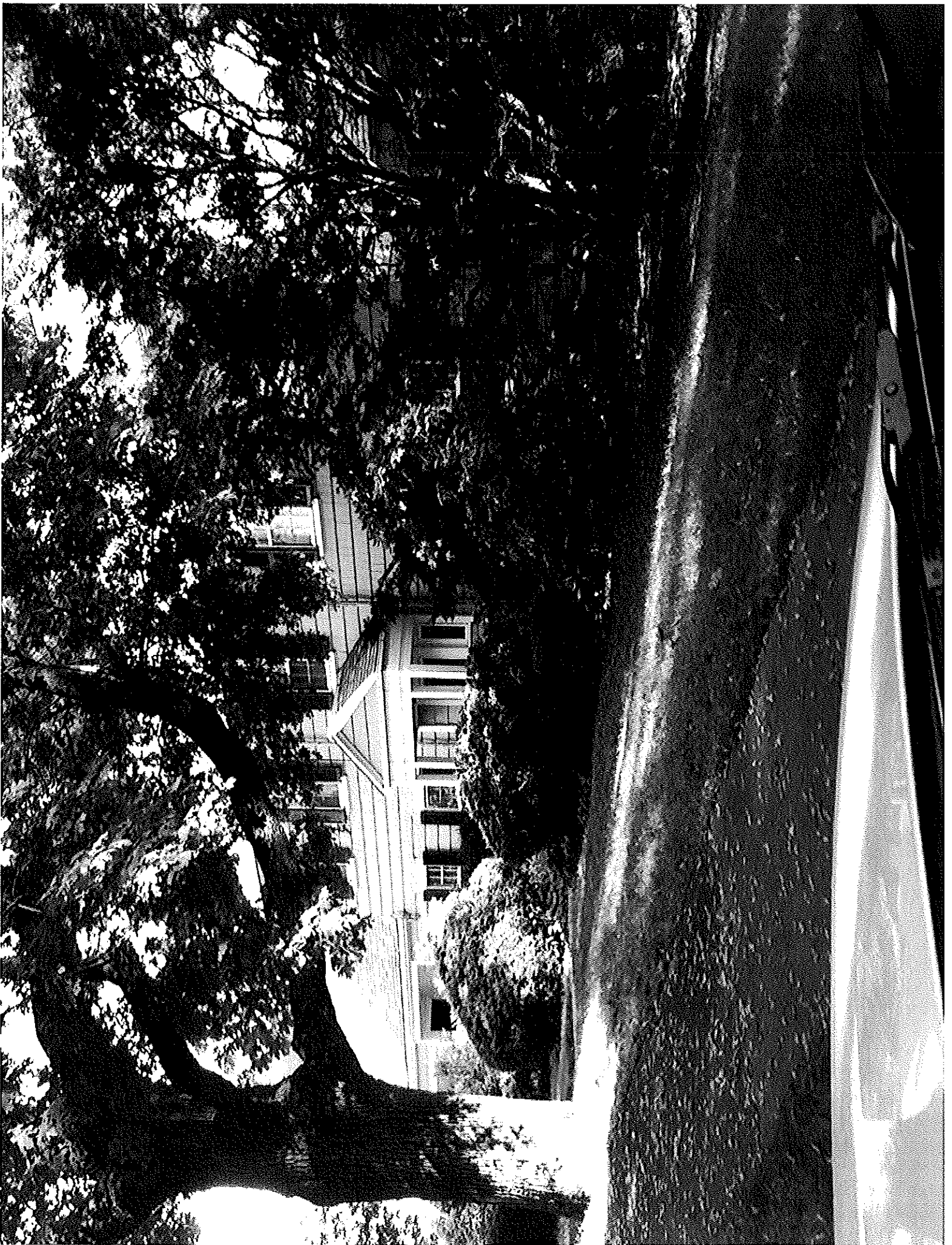
