Because there was no objection to granting West Valley City's Cross-Motion for Summary Judgment, the relief requested by West Valley City—an order "dismissing Plaintiffs' Complaint as a matter of law"⁵—is awarded.

IT IS HEREBY ORDERED that the Report and Recommendation⁶ is ADOPTED. West Valley City's Cross-Motion for Summary Judgment⁷ is GRANTED and Mr. Timilsina's Motion for Summary Judgment⁸ is DENIED. The above-captioned matter is DISMISSED with prejudice.
