Magistrate Judge Wells' recommended Plaintiff Michael A. Bacon's Second Amended Complaint be dismissed for "lack of ripeness and subject matter jurisdiction as [Mr.] Bacon had not fully pursued available state-court remedies." Mr. Bacon filed an filed an Objection<sup>2</sup> and Memoranda<sup>3</sup> in Support of his Objection. In his Memorandum in support of his Objection, Mr. Bacon attempts to alter his complaint to include an allegation that the Defendants violated his Fourth Amendment rights. On June 5, 2018, the Report and Recommendation was adopted and Mr. Bacon's untimely request to amend the complaint was not considered. A Judgment was entered and the case was closed.

Mr. Bacon seeks to alter or amend<sup>8</sup> the Judgment. He argues he timely made a motion to amend his complaint prior to the Report and Recommendation.<sup>9</sup> Mr. Bacon makes this same argument in his Objection to the Memorandum Decision and Order Adopting Report and Recommendation.<sup>10</sup> This argument lacks merit—the Second Amended Complaint was dismissed because Mr. Bacon failed to exhaust state remedies. Amending his complaint for the third time would not change the fact that Mr. Bacon failed to exhaust state remedies.

IT IS HEREBY ORDERED that Mr. Bacon's Motion<sup>11</sup> is DENIED.
