The Report and Recommendation<sup>1</sup> issued by United States Magistrate Judge Brooke Wells on May 28, 2015 recommends that this case be dismissed for want of jurisdiction.<sup>2</sup> Specifically, Magistrate Judge Wells found that the amount in controversy requirement is not met and found that there is no federal question jurisdiction.

The parties were notified of their right to file objections to the Report and Recommendation within 14 days of service pursuant to <u>28 U.S.C. § 636</u> and <u>Fed. R. Civ. P. 72</u>. As of the date of this Order, no objection has been filed to the Report and Recommendation.<sup>3</sup>

De novo review of all materials, including the record that was before the magistrate judge and the reasoning set forth in the Report and Recommendation, has been completed. The analysis and conclusion of the magistrate judge are correct and the Report and Recommendation will be adopted.
